AFFORDABLE CARE: The Catholic tradition affirms that health care is a basic right flowing from the sanctity and dignity of human life. Millions of Americans continue to go without health care coverage in our nation. Over 48 million people lack health insurance. As provisions of the Affordable Care Act are implemented the uninsured rate has dropped some. The provision to expand Medicaid in the Affordable Care Act is expected to have the one of largest impacts on reducing the number of insured along with the creation of the health insurance exchanges. Although the law mandated that states expand their Medicaid coverage to most people living at or below 138 percent of the federal poverty level, the decision by the U.S. Supreme Court in June 2012 removed the mandated expansion and gave states the option of expanding eligibility for their Medicaid programs.

Catholic teaching supports adequate and affordable health care for all, because health care is a basic human right. Health care policy must protect human life and dignity, not threaten them, especially for the most voiceless and vulnerable. Health care laws must respect the consciences of providers, taxpayers, and others, not violate them. Coverage should be truly universal and should not be denied to those in need because of their condition, age, where they come from or when they arrive here. Providing affordable and accessible health care that clearly reflects these fundamental principles is a public good and moral imperative.

Contact your federal representative and senators and ask them to end the government shut down and pass a clean continuing resolution that does not include any policy riders. Congress needs to stop playing political games on the backs of the poor. The government shutdown is causing very real harm to the most vulnerable in our country, including women, infants and children who have lost access to WIC programs, the poor around the globe as the Millienium Challenge Corporation goes dark, and workers who have lost the benefits of OSHA and NLRB oversight. Proposals to open some government agencies, such as those that manage national parks and monuments, do nothing to alleviate the suffering being inflicted on the working poor. The credibility of any country is determined by how it treats the most vulnerable. Congress is causing great damage to any credibility the U.S. may have as a moral authority in the world.

Also urge them to pass the Health Care Conscience Rights Act (H.R. 940. S. 1204) to address concerns regarding the Health and Human Services mandate for contraception coverage in any health plans offered under the ACA.
